Sustainability Advisory Committee May 13, 2026

Call to Order: by Reeta Singh at 6:31 pm

Approval of 4/8/26 Minutes: Motion by Eunice to approve April 8th meeting minutes, 2nd by Cindy.

Discussion: Bob provided revision for Rob to make regarding updated wording to the Action Item: "...City Council equip planners with the necessary resources to implement Environmental Guidelines for Land Development in Clemson, as specified in the attached document...".

Vote: All votes in favor of approval of minutes upon revisions discussed are made.

Public Comment: 3 speakers present

1. Clemson City Mayor Robert Halfacre thanked the Sustainability Advisory Committee for the recommendations brought forth to City Council regarding potential additions to environmental guidelines for land development in Clemson for city planners to utilize in future land development activities.
2. Clemson University Graduate Student Association President, Kazi Jewel Rana to voice interest in collaborating with the Sustainability Advisory Committee and Clemson University's various student-led sustainability organizations. Reeta made mention of the Sustainability Summit / Earth Forum in October as a pre-planned upcoming event for all groups to come together and discuss potential opportunities for collaboration.
3. Clemson City, Clemson Downs Resident shared concerns regarding Mosquito Fogging in their neighborhood. Discussed both environmental and public health concerns, scheduling, and residents' ability to opt out of spraying on their property(ies). Resident has surveyed Clemson Down community to attempt to obtain majority vote to opt out of mosquito fogging but has been unsuccessful and would hope that Clemson Down management would work with residents that have a preference either way to offer an alternative to chemical spraying, or otherwise only spray properties that specifically "opt in". Resident made request to the Sustainability Advisory Committee to consider developing/providing formal advise to the City regarding environmental considerations of Mosquito pest control.
4. Clemson Elementary Students & Girl Scout Troop 3218 members - Anna Rapp, Finley Simoneaux, and Stella Kate Dyer - presented on the Girl Scout's "Silver Award Project" promoting the City of Clemson's effort to become NWF certified. A primary objective of the project was/is to educate residents on the ease and benefits of certifying their own properties. The Troop provided copy of brochures that were distributed throughout neighborhoods (over 100 informational bags handed out to local area families) and presented on the Clemson Elementary's STEM Fest (back in March). Over 56 hours were spent on this project.
