**Call to Order:** The meeting was called to order by Madame Chair Lisa Robinson @ 6:00pm.

**Roll Call:** Roll was called by Madame Chair Lisa Robinson. Jacquie Myers and Ava Ross have excused absences. All other members in attendance. Welcome to our CU representative Caroline Beatty.

**Approval of Agenda:** Pablo Unda made motion to approve agenda. Seconded by Winton Hunter. Motion carried unanimously.

**Approval of previous meeting minutes – July 24, 2025:** Kevin Dull made a motion to approve. Winton Hunter seconded. Motion passed unanimously.

**Citizen Comments:** No citizen's comments or questions presented.

**Active Shooter Presentation:** Lt. Gooch with CPD gave a demonstration on active shooter preparation. From 1992 - 1997 Lt. Gooch served in the US Army. He has been with Clemson Police Department from 1999 to present. [FBI.gov/survive](https://www.fbi.gov/survive) If you can get out, get out. Fighting is last resort. Do whatever you can go get out, block entrances and exits if you need to hide.

**Department Status / Staffing Review:** Chief Campos provided a synopsis of current matters with the Department.

- 3 officer vacancies
  - One officer starting next week
- Held interviews for vacant positions this week and have two candidates in background
- 2 officers in academy due to graduate this month
- 1 dispatch position opening tonight due to one retiring
- New cars are in and striped they have been sent to the upfitters for the rest of the equipment
- Due to the alleged drink spiking from last year, we have starting offering the green screen kits in conjunction with the Panhellenic group. It has blood and urine sample kits to test.
  - The person being tested has to pay for the collection of the samples but not the testing.
  - CUPD has these as well

**Crime Review:** Chief Campos gave a rundown of the crime statistics for July and August 2025.

- July
  - 4100 calls for service
  - 756 traffic stops
  - Just shy of 400 citations
  - 14 DUI arrests
  - 15 MIP
  - 1 Noise Violations issued
  - 47 vehicle accidents
    - 13 with injuries
  - 7 mv thefts
  - 6 drug violations
- August
  - 860 stops
  - 564 citations
  - 2 robberies
  - 2 aggravated assault

- 13 simple assault
- 2 break ins
- 1 mv theft
- 7 drug violations
- 18 DUI arrests

Crime map is still not active on the website.

**Discussion of New Sub-Committee rules:** City administrator sent a memo to the board and commissions chairs. No board or commission may form any subcommittee or mission group without permission from city administration and your board support person. The reason is for transparency. Any sub group also has to be recorded and reported for legal reasons like any regular meeting.

**Golf Cart Ordinance Update:** The city ordinance passed. We stopped several golf carts during the LSU game and cited several for violations. There was one towed because it was not permitted through the state and had no insurance. We observed golf carts being used as taxis and that is not allowed in the city so they were cited for that.

**Parking Deck Ordinance Update:** Chief Campos advised we are back to the drawing board on a parking deck ordinance due to legality and issues with enforcement.

**Requested Presentations:** None presented.

**Board Member Open Discussion:** Sandy Edge asked, in ref to the code of conduct, questions about setting public comments time limits. He also asked about the line mentioning members of boards not attending or participating in other meetings.

**Adjournment:** Kevin Dull made a motion to adjourn. Motion was seconded by Sandy Edge and carried.
